This Amendment #004 is raised to Issue Addendum #03

Please see Addendum #03 attached.

The addendum will form part of the contract documents.

All other terms and conditions remain unchanged.

The following changes in the tender documents are effective immediately. This Addendum will form part of the contract documents.

- Q1:** Are the current cells onsite constructed to the standards outlined in Figure 11?
A1: Yes, with the exception of areas of the berms that have been removed for water drainage or vehicle access. As per Dwg 11, the contractor is required to repair the cells prior to use.
- Q2:** Can we receive a detailed drawing for the 12in Steel line that requires capping and the 4in gate valve that needs to be replaced?
A2: See Drawings Attached to Amendment #2 previously issued.
- Q3:** It is our understanding that the previous contractors onsite decommissioned liners and some berms of 4 of the cells. Can you please confirm the condition of each cell and pictures if available?
A3: New liners and bedding sand will be required for the cells as per Dwg 11. No pictures are available.
- Q4:** Can you please identify on the drawing where Cell 6 will be constructed?
A4: The location of Cell 6 will be determined following the completion of the soil disposal and excavation tasks.
- Q5:** Is there material onsite that can be used to construct Cell 6, or does this material for berms and above the liner need to be imported?
A5: Material needs to be imported.
- Q6:** Is there adequate road access to each of the cells?
A6: To be determined by the contractor at the site visit. In previous work programs on the site, vehicles have been able to access the cells.
- Q7:** Does the client have any pictures of the current road conditions?
A7: No, can be viewed at the site visit.
- Q8:** Are we able to treat material onsite or must all material, if required, be treated offsite?
A8: The Contractor may add amendments to the material onsite prior to transporting offsite.
- Q9:** Can you confirm what additive was used and to what concentration when previously amending the hazardous waste in cells 3A, 3B, 4 and TF#1.
A9: No, additives used on former phases of the site are proprietary.
- Q10:** I would like to ask for a 1 week extension to the Bid closing date.
A10: No extension to the Bid closing date is granted.
