1) Solicitation amendment:

1a. At Part 2, of the solicitation, "**Bidder's Instructions**",

Delete: Article 2.6(c), in its entirety, and

Insert: (c) Bidders are requested to communicate with the Contracting Authority no later than **14 December 2018**, 2018 by 2pm EST to confirm attendance and provide the name(s) of the person(s) who will attend. Bidders may be requested to sign an attendance sheet. Bidders who do not attend or do not send a representative will not be given an alternative appointment but they will not be precluded from submitting a bid. Any clarifications or changes to the bid solicitation resulting from the site visit will be included as an amendment to the bid solicitation.

1b. At Attachment 4.1, of the solicitation, "**Bid Evaluation Criteria**",

Delete: Article 1.1, M2, in its entirety, and

Insert: The Bidder must demonstrate that they have been in operation as an organization (including, but not limited to, a business, corporation, agency, or independent medical professional) for a minimum of three (3) years.

To demonstrate compliance, the Bidder must provide: a copy of the articles of incorporation; or, their procurement business number; or, their registered GST/HST account number.
