PART 1 - GENERAL INFORMATION

1.1 Requirement

The requirement is detailed under Article 6.2 of the resulting contract clauses.

1.2 Debriefings

2.4 Enquiries - Bid Solicitation

All enquiries must be submitted in writing to the Contracting Authority no later than 8 (eight) calendar days before the bid closing date. Enquiries received after that time may not be answered.

Bidders should reference as accurately as possible the numbered item of the bid solicitation to which the enquiry relates. Care should be taken by Bidders to explain each question in sufficient detail in order to enable Canada to provide an accurate answer. Technical enquiries that are of a proprietary nature must be clearly marked "proprietary" at each relevant item. Items identified as "proprietary" will be treated as such except where Canada determines that the enquiry is not of a proprietary nature. Canada may edit the question(s) or may request that the Bidder do so, so that the proprietary nature of the question(s) is eliminated, and the enquiry can be answered to all Bidders. Enquiries not submitted in a form that can be distributed to all Bidders may not be answered by Canada.

2.5 Applicable Laws

ANNEX "A" REQUIREMENT

1.0 SCOPE

1.1 Objective

Royal Military College of Canada (RMC), Department of Physics and Space Science has a requirement for supply and delivery of one (1) Pyroelectric Camera.

1.2 Background

A Pyroelectric Camera is required to obtain the profile of a CO2 beam in the mid-infrared spectrum. Currently, the profile is estimated with a knife-edge technique, which does not have the precision required to obtain a beam spot size. We have three (3) class IV CO2 lasers in our laboratories and cannot rely on the knife-edge technique to characterize our laser beams. Additionally, a Pyroelectric Camera is used as a CO2 laser maintenance and diagnostic device to determine if the quality of a laser beam has deteriorated and requires a gas refill.

2.0 GENERAL REQUIREMENT

Royal Military College of Canada (RMC), Department of Physics and Space Science requires one (1) Pyroelectric Camera that must satisfy the mandatory requirements specified in Section 2.1.

2.1 Mandatory Requirements

Deliverable: The Pyroelectric Camera must meet or exceed each of the following specifications:

- 1) Working range: 8 μ m to 12 μ m (min)
- 2) Must be adaptable to a window assembly to protect the sensitive portion of the camera
- 3) Damage threshold peak power density: 8W/cm² (min) in chopped CW mode operation
- 4) Damage threshold peak power density: 4W/cm² (min) in pulsed CW mode operation
- 5) Damage threshold over the entire array of the Pyroelectric Camera must be 2W minimum
- 6) Case dimensions: Length 150mm (max) x Width 150mm (max) x Height 150mm (max)
- 7) Active area: 12.5mm x 12.5mm (min)
