This amendment is being raised to answer the following questions and make the following changes to solicitation 5P421-180773/A:

1. Questions and Answers

Question 1

Will you accept a bid for only the red cedar rough portion?

Answer 1

No, the full requirement of lumber as outlined in Annex "A" – Requirement must be met. We cannot accept just the red cedar portion as we will need everything to build the board walk.

Question 2

Is there any leeway on the delivery as that amount of red cedar to be developed in less than a month as well as delivered to the North would be almost impossible?

Answer 2

Mandatory delivery date changed to March 10, 2019.

Question 3

I would imagine this is all to be used outside so as long as the material is under 19% moisture count it should be satisfactory for your usage.

Answer 3

All material must be Kiln Dried with less than 19% moisture content. After the lumber is dropped off in Nahanni Butte it will be flown to its final location so it is very important that the lumber stay dry. All lumber must be wrapped prior to shipment with high quality polyethylene woven wrap.

Question 4

#1 is 6x6 x 12 ft nominal dimension rough sawn red cedar.
Conflicting nominal dimension....
Calls for rough cut, do you want it at rough 5.5 x 5.5 inches

Answer 4

We require 6 x 6 inches rough sawn Western Red Cedar. Delete the word "nominal".

Question 5

#2 again nominal dimension
Do you want this rough at 1.5 x 3.5 actual size?

Answer 5

We require 2 x 4 inches rough sawn Western Red Cedar. Delete the word "nominal".

Question 6

#5 calls for dimension rough sawn,
Do you want this at 1.5 x 6 actual size?

Answer 6

We require 2 x 6 inches rough sawn Western Red Cedar.

Question 7

#6 calls for dimension s4s 2x6
Do you want this dressed to 1.5 x 5.5?

Answer 7

We require this to be dressed on all four sides to 1.5 x 5.5 inches Western Red Cedar.

Question 8

#14 calls for nominal dimension rough 6x6, is this to be rough at 5.5x5.5

Answer 8

We require 6 x 6 inches rough sawn Western Red Cedar. Delete the word "nominal".

Question 9

#15 calls for dimension 4x4, you want this s4s at 3.5x3.5

Answer 9

We require this to be dressed on all four sides to 3.5 x 3.5 inches Western Red Cedar.

Question 10

#16 calls for dimension 2x6, you want this s4s at 1.5x5.5

Answer 10

We require this to be dressed on all four sides to 1.5 x 5.5 inches Western Red Cedar.

Question 11

All material to be #2 and better as NLGA grading book?

Answer 11

Confirmed all material must be Grade #2 and better as per the National Lumber Grades Authority (NLGA) Standard Grading Rules For Canadian Lumber (2017 edition).

REQUIREMENT

Background:

For the supply and delivery of various dimensional lumber, Grade # 2 fir/spruce, and Cedar rough sawn for the purpose of building a board walk to be delivered to Nahanni National Park Reserve, Nahanni Butte Airport. A map with coordinates is provided to show the drop off location.

The exact location of the drop off at the airport will be defined at contract award.

Must be delivered between the hours of 8:00am and 4:00PM

Lumber must be delivered no later than March 10, 2019.

Supplier must unload and stack material.

COMPLIANCE MATRIX – MINIMUM MANDATORY PERFORMANCE SPECIFICATIONS

A complete list of the minimum mandatory performance specifications are detailed below in the "Compliance Matrix". Bidders are to clearly demonstrate compliance with each mandatory specification.

1. Bidders **must** show compliance by addressing each performance specification in the Compliance Matrix, whether the product offered "meets" or "doesn't meet".
2. Bidders are requested to indicate how they meet each performance specification by recording this information under the Performance Specification Offered column in the Compliance Matrix.
3. It is requested that supporting technical documentation, including but not limited to, specification sheets, technical brochures, photographs or illustrations be provided with the bid at solicitation close and be cross-referenced on the Compliance Matrix for each performance specification to outline where in the supporting technical documentation it demonstrates compliance. It is the Bidders responsibility to ensure that the submitted supporting technical documentation provides

detail to prove that the proposed product(s) meet the requirements of the Performance Specification. If published supporting technical document is not available, the Bidder should prepare a written narrative complete with a detailed explanation of how its bid demonstrates technical compliance.


4. If the supporting documentation referenced above has not been provided at bid closing, the Contracting Authority will notify the Bidder that they must provide supporting documentation within two (2) business days following notification. Failure to comply with the request of the Contracting Authority within that time period, will deem the bid non-responsive and the bid will be given no further consideration.
5. Bidders must address any concerns with the performance specifications in written detail to the Contracting Authority before bid closing as outlined in the Request for Proposal (RFP) document.
6. Failure to meet each mandatory performance specification will result in the bid being deemed non-responsive, and be given no further consideration.
