The following changes in the tender documents are effective immediately. This addendum will form part of the contract documents.

1. Response to RFI:

Q1: Can you please provide more detailed direction on what elements: gas, fibres etc the monitoring is trying to detect? Is full time monitoring required for all portion of work? Eg. Would monitoring be required when contractor is removing or reinstalling kitchen equipment, dining tables, installing plywood wall hoarding or masking and sealing of rooms or installing ventilation ducting?

Comply with specification section 01 35 33 for health safety requirements and handle hazardous materials and abatement according to specification section 02 81 01. Two air "sampling" procedures are required under section 02 81 01, silica air sampling during the vinyl, and ceramic floor tile removal and total volatile organic compounds (TVOCs) sampling during MMA flooring installation.

Full time monitoring is required when potential for silica dust is generated and when MMA flooring is being installed. Background samples will be collected prior to start of silica construction activities. Monitoring during MMA flooring is required to mitigate any odor concerns outside Work Area. Monitoring will not be required when removing or reinstalling kitchen equipment and dining tables; installing and removing plywood walls for hoarding or masking and sealing of rooms or installing ventilation ducting.
