Addendum No. 1

1. **QUESTIONS AND ANSWERS**

Question 1. Can you provide a historical breakdown of the number and nature of work requested for each location?

Answer 1. Cannot provide breakdown, all work requests and quantities varies from year to year and location to location.

Question 2. Is there a requirement for written and verbal communication to be conducted in both French and English?

Answer 2. Communication has been in English.

Question 3. Appendix 1 identifies the total estimated number of hours for each labour category. Could you please further break down these estimated hours for each trade by location?

Answer 3. There are no set amount of hours used by each trade at these locations, we only issue requests when an issue arises.

Question 4. Supervision is expected to be included in the overall charge rate for each labour category. Can you please explain what your specific expectations are for the supervision of work? Do you require a dedicated supervisor for the project?

Answer 4. The Supervisor is the person we deal with on a daily basis and who is expected to view the work, plan and inspect the work completed, insure the paper work is completed and deal with any sub-contractor, municipality, etc. pertaining to the work request. The supervisor is also expected to ensure all time sheets and material invoices are sent in when invoicing.

Question 5. Appendix 1 calls for the Labourer rate to be charged at 50% of the Carpenter rate. Can you please explain your reasoning for this requirement as this is not our current practice in NB? Apart from our mandate to attract and retain competent Labourers, there are a number of similar fixed costs that must be associated with each of these labour categories that would greatly stress this charge rate differential requirement.

Answer 5. This is our requirement which we have asked for as stated in the Specification and Basis of Payment.
