SOLICITATION AMENDMENT No. 003

This solicitation amendment No. 003 is raised to:

- 1) publish questions and answers that have been received in relation to this solicitation.

- 1) The following Questions and Answers have been provided:

QUESTION 1:

"Who is the incumbent (aka current provider)?"

ANSWER 1:

The provision of medical services is a new requirement for this region, hence there is no incumbent.

QUESTION 2:

"Hours of medic professionals: I see that Nurses (up to 6) will be at BCIHC 24 hours a day 7 days a week, and note that the other medical providers like physician and psychologist etc. have requirements to be available for a # of hours over a # of days. From a scheduling point of view, would like some clarity as to how this is practically put in place. Would imagine these services are called (on call) as they are needed.

What kind of notice and time frame is provided for those professionals to respond to need or are they expected at BCIHC while on duty? If it could be clarified, then that would be appreciated.

Aka – Physician based on hours below is 78 days over year (12 hours shift)

Nurse – 364 days (12 hour shift)

Psychologist –156 days (based on 4 hour stints"

ANSWER 2:

The only services that are on an 'as required' basis are those of the psychiatrist.

The physician must be on-site 4 days per week in three hours shifts for a total of 12 hours per week. A gap of no more than two days of service is acceptable.

Nursing services must be provided 24/7.

A psychologist must provide 4 hours of service per week, either in one shift of four hours or shifts split accordingly (i.e., two 2-hour shifts).

ALL OTHER TERMS AND CONDITIONS REMAIN THE SAME.
