Here are the questions we have received and the answers :

Question 1 : Will we be able to bid on projects to design drawings and specifications if the proposed resource for performing enhanced commissioning is not part of our design team?

Answer 1 : We wish to establish Standing Offers as the projects are not know at this time. An assessment will therefore be made on a case-by-case basis in time and place to determine if there is a conflict of interest under the 2010B General conditions sections 27 and 28 (<https://buyandsell.gc.ca/policy-and-guidelines/standard-acquisition-clauses-and-conditions-manual/3/2010B/18#conflict-of-interest-and-values-and-ethics-codes>). In order to avoid situations of conflict of interest, among others, we intend to issue 2 Standing Offers by zone.

Question 2 : Do we have to offer 2 mechanical resources AND 2 more electrical resources or is it a minimum of 2 resources for one or the other?

Answer 2 : As per Attachment 2 of the Request for Standing Offer,

a) *The Offeror must propose at least two resources in the mechanical category who hold a bachelor's degree in mechanical engineering and/or a college diploma in building systems technology.*

AND

a) *The Offeror must propose at least two resources in the electrical category who hold a bachelor's degree in electrical engineering and/or a college diploma in electrical engineering or any other related field of study.*
