2.3 Enquiries - Bid Solicitation

All enquiries must be submitted in writing to the Contracting Authority no later than five (5) calendar days before the bid closing date. Enquiries received after that time may not be answered.

Bidders should reference as accurately as possible the numbered item of the bid solicitation to which the enquiry relates. Care should be taken by Bidders to explain each question in sufficient detail in order to enable Canada to provide an accurate answer. Technical enquiries that are of a proprietary nature must be clearly marked "proprietary" at each relevant item. Items identified as "proprietary" will be treated as such except where Canada determines that the enquiry is not of a proprietary nature. Canada may edit the question(s) or may request that the Bidder do so, so that the proprietary nature of the question(s) is eliminated, and the enquiry can be answered to all Bidders. Enquiries not submitted in a form that can be distributed to all Bidders may not be answered by Canada.

STATEMENT OF REQUIREMENT

A1. Background

CORCAN is a key rehabilitation program of the Correctional Service of Canada, with a mandate to aid in the safe reintegration of offenders into Canadian society by providing employment and employability skills training to offenders incarcerated in federal penitentiaries. CORCAN provides the opportunity for offenders to develop employment skills through vocational and on-the-job skills training in our four business lines (Manufacturing, Textiles, Construction and Services) during their incarceration. To continue supporting employment and employability skills training, a replacement Edge Bander is required for the Manufacturing business line at CORCAN Community Industries - Moncton

A2. Requirement

Supply and Install an Edge Bander at CORCAN Community Industries - Moncton.

A4. Technical Training

The Contractor must provide employees covering the safe and proper operation of the unit after delivery and acceptance of the unit has occurred. This training will be coordinated between the Project Authority and the Contractor's Representative occur within ten (10) working days of the delivery and acceptance of the unit.

A6.1 Service Technician must be available within 48 hour to location.
