It is mandatory that the Bidder or a representative of the Bidder visit the work site. The bidder should provide a resume or a written understanding to demonstrate adherence to the following mandatory requirements at solicitation closing. Failure to meet any of the following mandatory criteria will render your submission non-compliant and will be given no further consideration.

The Bidder must have:

1. Experience in maintaining a minimum of 15 cooks for 3 or more projects in the past 10 years; and
2. Previous experience managing High Volume Meal Preparation activities for 3 or more large* projects in the past 10 years. (*"large" is defined as a project managed where 1000 or more persons were fed 3 or more meals per day, for a period of at least 10 consecutive days).
