Revision 001

This revision 001 is raised to extend the closing date of Request for Proposal (RFP) and to provide questions and answers.

1. The closing date of Request for Proposal is extended to January 24, 2018 as specified on the cover page of this revision.

2. Questions and Answers

Question 1:

Would it be possible to extend the solicitation period beyond 14-01-2019 14h00?

Answer 1:

The solicitation period is extended as per Article 1.

Question 2:

Would it be possible to bid with an hourly rate excluding the hangar fees?

Answer 2:

No. Responsibility for hangar fees is described in paragraph 10 of Annex A.

Question 3:

Would it be possible to bid with a daily rate for the support personnel (pilot, mechanic, etc.), excluded from the hourly rate?

Answer 3:

No. Contractor must submit a firm all-inclusive hourly flying rate, excluding fuel, as described in Annex B.

Question 4:

Who is responsible for costs associated to the flight permits, work permits, and NAFTA agreements when required?

Answer 4:

The direct expenses incurred in the performance of the Work are reimbursable as described in paragraph 4 of Annex A.

Question 5:

Is there a guaranteed minimum of 10h of flight per mobilisation or is this only an estimate?

Answer 5:

There is not minimum guaranteed hours per mobilisation. The minimum work guarantee is described in paragraph 7.2.5.

Question 6:

What is the duration of a mobilisation in Quebec, including installation and removal of equipment?

Answer 6:

Typical ground mobilisation of installation and removal of equipment is half a day each. Typical duration of operations in the Quebec area is from one (1) to five (5) days.

Question 7:

Do you have planned flights immediately at the beginning of the contract?

Answer 7:

As described in paragraph 7.2.1.1

All other terms and conditions remain unchanged.
