QUESTION:

In item 8.7 regarding Air Bike user weight, Canada has requested the user weight of 275 to 325 lbs, will you accept the user weight of 350 lbs?

ANSWER: Yes

As a result of the above inquiry, the specification in TABLE at Annex "A" is amended as follows:

DELETE: Item 8.7 IN ITS ENTIRETY.

INSERT: 8.7 User Weight: minimum 275 lbs. up to maximum 350 lbs.

QUESTION:

In item 8.12 respecting Air Bike console monitor display, Canada has requested 4 to 8 pre-set programs, will you accept the instrument with 9 programs?

ANSWER: Yes

As a result of the above inquiry, the specification in TABLE at Annex "A" is amended as follows:

DELETE: Item 8.12 IN ITS ENTIRETY.

INSERT: 8.12 Performance Console Monitor must be able to display at a minimum the following:

- Heart rate
- 4-9 pre-set programs
- Calories
- Time
- Distance

QUESTION:

Regarding the Adaptive Motion Trainer, is Adjustable stride height from 6.8 to 10 inches acceptable?

ANSWER: Yes, as long as it meets or exceeds requirement at Item 6.10.

QUESTION:

Regarding the Air Bike, is max Length: 59", Max Width: 30" acceptable?

ANSWER: Yes, as long as it meets or exceeds requirements at Items 8.4 and 8.5.
