This Amendment is raised to publish questions and answers.

Group 1 - 500cc; 2 passenger; gas

Q1: Would you be willing to accept a length of 113 inches?

A1: Yes, length of 113" is acceptable

Q2: Would you be willing to accept a width of 56.5 inches?

A2: Yes, width of 56" is acceptable

Q3: Would you be willing to accept a wheelbase of 72.8 inches?

A3: Yes, wheelbase of 72" is acceptable

Q4: Would you be willing to accept only single beam headlights?

A4: Yes, but only with the addition of forward facing auxiliary work lights on the left & right side of the UTV

Q5: Would you be willing to accept only a single rear tail light?

A5: No, a single rear tail light is NOT acceptable

Q6: Would a machine with Two (2) single beam headlights and Two (2) Taillight/Braking be acceptable for this group?

A6: Yes, but only with the addition of forward facing auxiliary work lights on the left & right side of the UTV

Q7: Would a machine that does not have the option of power dump box be acceptable for this group?

A7: NO, the power dump box is a mandatory option

Q8: Would a machine that utilizes a two latch system for the box tailgate be acceptable for this group?

A8: Yes, a two latch system is acceptable

Group 2 - 795cc; 2 passenger; gas

Q1: Would you be willing to accept only single beam headlights?

A1: Yes, but only with the addition of forward facing auxiliary work lights on the left & right side of the UTV

Group 3 - 795cc; 4 passenger; gas

Q1: Would you be willing to accept only single beam headlights?

A1: Yes, but only with the addition of forward facing auxiliary work lights on the left & right side of the UTV

Group 4 - 795cc; 4 passenger, diesel

Q1: Would you be willing to accept only single beam headlights?

A1: Yes, but only with the addition of forward facing auxiliary work lights on the left & right side of the UTV

Group 5 - 900cc; 2 passenger; gas

Q1: Would you be willing to accept an engine size of only 812 cc?

A1: No, Approval has previously been given for a decrease of engine displacement to 875cc. A unit with an engine displacement of 812cc would fit within Group #2

Group 6 - 900cc; 2 passenger; diesel

Q1: Would you be willing to accept an engine size of only 854 cc?

A1: Yes; a decrease of engine displacement to 854cc is acceptable

Q2: Will a machine with 898cc be acceptable for this requirement?

A2: Yes, a displacement of 898cc is acceptable
