REQUEST FOR QUOTATION AMENDMENT NO. 002

Request for Quotation Amendment no. 002 is raised for the following reason:

- To address questions pertaining to security requirement;
- To address questions regarding the Touch Screen specifications;
- To insert the PowerPoint used during the Bidder's Conference as an attachment to the Solicitation; and
- To amend 2BH869028 – Form 6 and 2BH869028 – Formulaire 6

Question 2

Could you offer any insight on whether the timeline for this procurement would allow us to obtain a valid Designated Organization Screening? Further, in responding to this RFP would there be an opportunity for a sponsorship for the Contract Security Program? And would personnel clearances be required?

Answer 2

The timeline to obtain a valid Designated Organization Screening could be up to 6 months; the timeline of this procurement would not be sufficient to ensure a valid Designated Organization Screening could be obtained prior to contract award. However, in responding to this Request For Quotation, there would be an opportunity for sponsorship for the Contract Security Program. Personnel clearances would be required, as per pg. 6, under Security Requirements, "(b) The Contractor personnel requiring access to sensitive work site(s) must EACH hold a valid RELIABILITY STATUS, granted or approved by CISD/PWGSC."

Question 3

In Form 6 V2 under B7 it is stated that monitors are required to have at minimum 300 cd/m² brightness while also stating in B10 that the monitor must be viewable "in all outdoor lighting conditions, including direct sunlight". In our experience any display under 1000 cd/m² (at a minimum) will be absolutely inadequate and that a 300cd/m² display will be unreadable in direct sunlight, regardless of anti-glare surfacing. We are concerned that quoting on proper "direct sunlight" viewable displays (which are more expensive than regular 300cd/m² displays) would put us at a disadvantage in the financial evaluation and may result in Canada inadvertently selecting a display that would not meet requirement B10.

Answer 3

The requirement listed under B10 will be removed.
