Connect exit sign to existing exit sign circuits by providing 2#12+GND-21mmC for AC circuit and 2#12-21mmC for DC circuit from existing exit sign located at Hatch #1.

Salvage existing main fire alarm control panel in its entirety and hand over to Departmental Representative.
