Answer 4: The United States Federal Government Per Diem rate does not apply to this requirement.

The budgeted rate is based on pricing paid under the current contract for this service. In keeping with the RCMP's obligations to respect the privacy of the current Supplier's

unit pricing, the room rates budgeted will not be divulged. Due to the recent

and significant increase to the volume of rooms required for this training, the revised financial threshold has warranted a publicly posted competitive process to ensure a fair, open and transparent process. The opportunity is open to any/all properties which meet
