### Part 3. Questions and Answers

The following question has been asked in response to the Request for Proposal and Elections Canada hereby answers as follows:

#### 3.1 Question No. 5

#### Question:

We would like to ask Elections Canada if the handle length of 131 cm (around 12.2 inches) and a diameter of 0.3 cm (0.762 inches) would be acceptable?

#### Answer:

A length of approximately 31 cm (12.2 inches) is acceptable for the handle. As for the diameter, it seems that there is an error in the question but a diameter of 0.31 cm (0.122 inches) is acceptable.

#### 3.2 Question No. 6

#### Question:

We have a suggestion for the bottom of the bag to have cardboards inside bottom of the bags. That makes the bags stronger and more durable

#### <u>Answer:</u>

Elections Canada agrees with the suggestion. A cardboard inside the bottom of the bag can be added as it would make the bag stronger and more durable. The bag must be able to carry 6 lbs (2.272 kg).


