ANSWER # 22:

Annex A, the Security Requirement Check List (SRCL), is for suppliers' information about security requirements regarding the solicitation. As such, the SRCL does not need to be submitted with the bid. However, in accordance with SI09 and SC01 of the Invitation to Tender (ITT), at bid closing, the bidder must hold a valid Designated Organization Screening (DOS), issued by the Canadian Industrial Security Directorate (CISD), Public Works and Government Services Canada (PWGSC). To facilitate verification by PWGSC, bidders are asked to indicate their Industrial Security Program Organisation Number on the Bid and Acceptance Form.
