This Amendment 007 to the Solicitation is raised to address the following questions received from a potential Bidder:

QUESTION:

The SportsArt treadmill I am quoting for the bid has a max user weight of 330lbs, but this is due to the breaking mechanism, not the actual overall weight the treadmill can handle, it is more so that if a user is over 330lbs the breaking mechanism may not work as well hence why the max user weight for specific treadmill is less. Is that okay, and if not I am trying to understand furthermore why the specifications are relatively high at 375-425lbs.

ANSWER: The Commercial Grade treadmills that we currently have and want to have moving forward are all between 375-425Lbs.

QUESTION:

The treadmill is 84.1 inches in length, I see on the specifications it has to be between 70-78. Can specifications be increased to 84.1?

ANSWER: Yes, the length specification is increased to 84.1 Inches.

QUESTION:

Treadmill incline is a fixed incline at 4", is that ok?

ANSWER: The incline requirement of the treadmill must be 0-18 degrees.

QUESTION:

With the AMT adaptive motion trainer, I have an even better product I am offering the SportsArt G886 Cross Trainer. The only thing with this product is the elliptical is 103 inches in length, other than that it passes everything. Is that ok?

ANSWER: Yes, the length specification is increased to 103 inches.
