1. Provide clarification and answers to questions from potential suppliers.

QUESTIONS AND ANSWERS:

Question 1	<p>“3.2.1 – Weather – The vehicle must start and operate under weather conditions in Canada in temperatures ranging from 0 to 40°C (32 to 104°F).”</p> <p>This style of unit is designed for indoor use and is rated from temperatures from zero to 40 degrees C. Outdoor use is not recommended.</p>
Answer 1	<p>This requirement is for indoor use only.</p>

Question 2	<p>“3.2.2 – Terrain – The vehicle must operate on use-roughened concrete floors, deteriorated outdoor paved surfaces while being used for moving general supplies in and around warehouses”</p> <p>These units are designed for indoor use only and given the wire guidance and under-clearance they are not recommended for outdoor use. Additionally the placement of the wire guidance means the unit must be used on smooth surfaces and roughened concrete is not permitted by manufacturers and health and safety due to operator safety & unit controls. Please accept “Terrain – unit to operate on smooth concrete floors”</p>
Answer 2	<p>This equipment will be used indoor on smooth concrete floor.</p>

Question 3	<p>In the purchase description, 3.15 Electrical System, it states that: (e) The battery charger must be capable of charging the forklift batteries from the designated source of a 550 volt, three phase, 60Hz power source;</p> <p>And following this section (i) states: (i) When requested by DND, the vehicle must be provided with battery charger capable of charging the forklift batteries from a 208 volt, three phase, 60 Hz power source.</p> <p>These are different chargers and are at different price points. Can you confirm the requirements for 2.1 are to specifically include (e), the 550v, 3 phase charger?</p> <p>2.1 Electric Motor Driven Swing-Reach Man Up with Order-Picking Forklift Truck</p> <p>A. The Firm Unit Price(s) include(s) associated specifications, training, and deliverables as per Annex A,</p> <p>Requirement, Delivered Duty Paid (DDP) specified Delivery Point, Incoterms 2010:</p> <p>Can you also confirm that the price required for the optional quantities 3.1 is where one would need to include provisions for the price to include (e), the 208v, 3 phase charger?</p>
Answer 3	<p>DND may request a 220V/3-phase or a 550V/3-phase charger for the firm quantity as well as the option quantity depending on the input power source available at the intended location.</p>

Question 4	<p>The validity period and current volatility in the US/EU & CAD Exchange rates leave both the Bidder and government in a position of great risk with no safeguards against the changes (see changes in the previous 90 Days). Will the client accept the standard bid exchange risk TWSPSC-450 form used in previous DND bids? Given the competitive nature of the bid process and evaluation criteria the client will receive the lowest price bids if this form/clause is included.</p>
Answer 4	<p>In accordance with S. 3.3.2 of the Request for Proposal, the requirement does not offer exchange rate fluctuation risk mitigation. Requests for exchange rate fluctuation risk mitigation will not be considered. All bids including such provision will render the bid nonresponsive.</p>

Question 5	The request is for unit pricing for transportation of the equipment at a provincial level. The cost to transport can vary greatly across the province and it is difficult to provide a single price for this. As an alternative, is it possible to provide specific (potential) delivery addresses? With this, we could provide more accurate pricing for the transport.
Answer 5	Destination for the option is unknown, a specific address cannot be provided. Transportation pricing for the option will remain as-is.
