Question 3:

- For your item# 5, is it possible to remove it in its entirety from the bid? The reason being is that a 30X30 HAT is very uncommon and a non industry size and for Qty:1. Or can you assign it as a different category all together?

Question 4:

item #5 is listed as:

Seated Range Height Adjustable Work Surfaces
with Casters
Telescopic
762mm (30 in./po) x 762mm (30 in./po)
Location: Room 346

With a height range of:

Height adjustability range to be min 23" – 48" [584mm – 1219mm]

As per the amendment 001, issued on January 22nd, 2019.

Would it be acceptable to provide a table that has a telescoping height range of 22" to 32" for this (1) item?

I am questioning the safety and stability of the range being able to adjust to 48"H. It appears that range was selected based on the electric height adjustable tables meeting this range and my concern is for the stability and safety of this range for a mobile table.

Answer to question 3 & 4:

- item #5 30" x 30" height adjustable table to be removed from the bid request.
