A) Question and Answers

Q1: RE: K3D33-190572/A RF Safety Code Assessment

Our company has been performing the RF Safety Code Assessments for the past 25 years. Our Safety Code 6 analyses use state of the art software and our Safety Code 6 RF Safety Reports have always been accepted by the RCN and DND.

The question that I have pertains to the requirement **M1**: Bidder must demonstrate experience providing RF Exposure Compliance Reports on behalf of clients in the ISEDC required format. And evaluation **PR3** which also asks for ISEDC format. Safety Code 6 RF Safety Analysis is the same for all Radar systems, whether they are for RCN or ECCC applications. Our expertise is in RF Safety Analysis, and we have produced many reports (all are Controlled Goods or CLASSIFIED) but none are in ISEDC format. Our reports contain all of the information required by Safety Code 6. Are only ISEDC format reports acceptable - or would references to our RCN reports be acceptable for M1 and PR3?

A1: ECCC will accept the alternative formats as long as the RF Exposure Compliance report has all the information required by Safety Code 6 guidelines and be accepted by ISEDC.

Q2: Annex B – Basis of payment indicates: “Scheduled RF Inspection Reports Due in accordance with ANNEX A, Section 3 and Appendix 9 to ANNEX A – Site measurement report deadline”

To my understanding, ANNEX A, Section 3 relates to: Firm Deliverables – Twenty Seven (27) SC6 Analysis and Reports. Which are listed at Appendix 1 to Annex A, not Appendix 9 to Annex A

Section 4 relates to Appendix 9 to Annex A.

The clarification provided on January 22nd does not correct this.

A2: Please see below for further information.

Q3: The General Clause 6.2.3 specifies a “Minimum Contract Value “ of \$55,000.00 while the selection calculation section 4.2 indicate examples with value lower than 55,000. Question: will we be rejected if we bid at a lower price than \$55,000?

A3: No. The Minimum contract value is associated to Canada's minimum financial obligation to expense under the contract. This value has no bearing on basis of selection or bid price.

B) Amend Annex B – Basis of Payment
