As allowed under Rule 1. F. Pre-Bid Interpretations, we are hereby issuing the following clarification to all plan holders. Unless defined herein the Standard Exclusions will apply; *General Contractors are responsible to include all work that may be excluded from a BidCentral Online Bidding for Subcontractor's (BOBS) Bid as they deem necessary.* This document does not imply a requirement to include work not specified:

#### **1. Closing Date, Time and Location**

The BidCentral Online Bidding for Subcontractors (BOBS) closing will be up to 3:00 PM local time on **February 4, 2019\***. For information refer to the BidCentral website at [www.bidcentral.ca/bobs](http://www.bidcentral.ca/bobs)

Note that the on-line Bid Form will not be available until one week prior to the BOBS closing.

\* For the purposes of the changes to the BOBS closing date, notifications of a change will no longer be issued by BidCentral Online Bidding for Subcontractors through a Pre-Bid Interpretation or otherwise. Any change to the BOBS closing date will be 2 Working Days prior to the amended General Contractor closing date. Users are responsible to monitor the BOBS Bid Module on BidCentral for an amended closing date (Closing Time will always remain at 3 PM). Where a deadline for notification to inform Users of a change to the General Contractor closing date cannot be accommodated a Pre-Bid Interpretation may be issued.

### **BidCentral Online Bidding for Subcontractors Sections and Divisions**

**(Bid Bonds, and Performance and Labour & Material Payment Bonds are required as per the BidCentral Online Bidding for Subcontractors Rules of Procedure)**

#### **Electrical**

Combined bids only to include:

Division 26 - Electrical

Division 27 – Communications

Division 28 – Electronic Safety and Security

Section 33 65 73 - Concrete Encased Duct Banks and Vaults

#### **Exclusions**

1. BOBS Rules of Procedure, Appendix A Standard Exclusions for Electrical shall apply (for example not limited to but precast vaults are excluded). General Contractors are to include as they deem necessary for any work excluded by a Trade Contractor.
2. Section 33 65 73, Clarification: this Bid shall also exclude formwork, mudslab, compaction and reinforcing rods. General Contractors will include for this work as they deem necessary.

#### **Security Clearance – Electrical Bidders**

Bidders are reminded that as per Special Instructions to Bidders, SI 09 and Supplementary Conditions, SC01 subcontractors are required to have the specified security clearance in order to be able to undertake work on site. Bidders will be required to confirm at the time of the BidCentral Online Bidding for Subcontractors bid closing whether they have the security clearance. The availability of the clearance is not a consideration of bid compliance for BidCentral Online Bidding for Subcontractors.
