B) QUESTIONS & ANSWERS

Q1 Can you provide us with test pit logs and sieve analysis.

A1 See DSP2_18-0527. Attached is a pit map that shows the approximate mining area and the testpits that are the closest to this area. The testing results for those pits are attached as well. This is all the info we have relative to the mining area

Q2 Can you give me the pit location

A2 See DSP2_18-0527 Pit Location attached map

Q3 The Specification is missing page numbers and spec sections as noted below. Please confirm if this is a clerical and/or provide any additional information that may be missing.

d) Also there are 2 pages that have the same number (Page 30).

A3 See DSP2_18-0527 revised specifications with the below changes

c) These pages have been deliberately removed. There were problems with the pagination of the document.

d) There were problems with the pagination of the document. I am unable to fix this without further issues in the pagination so it will be left as is.

Q4 Please provide a drawing for the location of the new/proposed Registration Building Park Lot at Whistler's Campground. This is required for elevations/area calculations for supplemental source of aggregates; mobilization/demobilization/access/egress to work area; traffic, safety & environmental plans; etc.

A4 Any reference to the Registration Parking Lot has been removed from the specs. Any source material from this area will be excavated and hauled to Marmot Pit and stockpiled. This stockpile will be used by this contract as additional source material to generate the required aggregates as part of this contract. An updated spec has been attached with all references to the Registration Building Parking lot removed.

Q5 For the designation 6 class 80 material available for use, what is the volume?

A5 Total quantity unknown at this point and to be confirmed in the pit. Not required for bidding of this

tender.

Q6 When can we expect design and layout drawings for registration building excavation?

A6 No. This has been removed from the contract. See A4 above.

Q7 Under working times in bid package, line 2. states Thursday March 18- Tuesday March 23. I believe this is a mistake, the 18th is a Monday and 21st is a Thursday. Should it be the march 21, 19:00 to March 26th 06:00?

A7 The dates need to be corrected – Thursday April 18th to Tuesday April 23rd. That is the Easter long weekend

All other terms and conditions remain unchanged.
