Solicitation Amendment No. 001

This solicitation is hereby amended to provide the following question and answer:

Q1. We would like to find out why this requirement was re-tendered again as it was originally posted in October, 2018 under solicitation 51019-184012/A?

A1. The current contract for Informatics Professional Services, delivered to Veterans Affairs Canada (VAC), expires on March 31, 2019. VAC wishes to enter into a longer term contract (contract period: 3 years with 2 optional 1 year periods), which would result from Request for Proposal (RFP) 51019-194001/A, posted January 21, 2019.

A contract of this length and cost, requires additional approvals and oversight, throughout the procurement process. As a result, a contract would not be awarded in time to replace the current contract. To address this delay, an RFP for Informatics Professional Services was posted in October, 2018, which is intended to serve as a bridge to cover the period until the longer-term contract that will result from RFP 51019-194001/A (posted, January 21, 2019), is awarded.

If your bid has already been forwarded and you wish to revise same, this revision should be sent in a sealed envelope and mailed to the above address and reach the undersigned before the appropriate closing date. The solicitation number and the closing date are to be shown on the outside of the sealed envelope.

All other terms and conditions of the solicitation document remain unchanged.
