**(1) Bidders' Questions and Answers**

**QUESTION # 23:**

SC01 states that contractor personnel requiring access to sensitive work site(s) must each hold a valid Reliability Status. Is the Insurance building considered a sensitive work site? Or is the tunnel considered a sensitive work site?

**ANSWER # 23:**

The Insurance building and the tunnel are considered sensitive work sites for the purposes of the security requirements.

However, the Bidders' personnel does not need to have the required security clearance at the time of bid closing. It is the responsibility of the successful Bidder to ensure that the security requirements of its personnel are met before the personnel requires access to the site. Canada will not be held liable or accountable for any delays or additional costs associated with the successful Bidder's personnel not having the mandatory security clearance.
