QUESTION 1:

Would Canada please consider removing the following requirement as it limits the pool of eligible bidders:

Part 7 - 14.15 The Contractor and the infrastructure provider must maintain Information Security Management (ISO 27001: 2013) certification or later.

RESPONSE 1:

No, LAC will not remove this requirement for Information Security Management. ISO 27001 is a recommended certification by Treasury Board of Canada for protecting unclassified data in the Cloud adoption strategy (Security Policy Implementation Notice (SPIN) – Direction on the Secure Use of Commercial Cloud Services).

QUESTION 2:

Could you please extend the closing date of this RFP by two weeks?

RESPONSE 2:

The decision was made to not extend the closing date for the RFP.
