This amendment has been raised to answer the following questions from industry and amend solicitation ET959-191328/A as follows:

Question

We have three (3) questions/concerns about the insurance requirements listed in Annex "G". If you can please advise the following:

- i) For "B. Automobile Liability Insurance" - Provincial legislation prohibits any addition of a Notice of Cancellation to an auto insurance policy. Please advise if this can be removed.
- ii) For "C. All Risk Property Insurance" – The agreement requires All Risk Property Insurance in the amount of \$2,000,000.00 for property that is not owned by the contractor. Our insurance broker advised that you cannot insure property that you do not own under All Risk Property Insurance, and that there would not be any coverage in the event of a claim. Please advise if this coverage can be removed.
- iii) For "D. All Risk in Transit" – The agreement is asking for \$2,000,000 in coverage per shipment. This coverage seems excessive as the coverage applies to loss or damage on a single trip. Can the coverage amount be reduced?

Answer

- i) Requirement for a Notice of Cancellation for Automobile Liability Insurance is deleted. Please see the following amendment.
- ii) Requirement for All Risk Property Insurance is deleted. Please see the following amendment.
- iii) Upon review of the requirement, it has been determined that All Risk in Transit Insurance coverage of a minimum of \$100,000 per trip is sufficient. Please see the following amendment.

The solicitation is amended as follows:

On page 69 of 70, under Annex "G", B. Automobile Liability Insurance:

Delete:

- d. Notice of Cancellation: the Contractor will provide the Contracting Authority thirty (30) days prior to written notice of policy cancellation or any changes to the insurance policy.

On page 68 of 70, under Annex "G", C. All Risk Property Insurance

Delete: in its entirety

On page 69 of 70, under Annex "G", B. All Risk in Transit Insurance:

Delete:

1. The Contractor must obtain on the Government's Property, and maintain in force throughout the duration of the Contract, All Risk Property in Transit insurance coverage for all applicable conveyances while under its care, custody or control, in an amount of not less than \$2,000,000.00 per shipment. Government Property must be insured on Replacement Cost (new) basis.

Insert:

1. The Contractor must obtain on the Government's Property, and maintain in force throughout the duration of the Contract, All Risk Property in Transit insurance coverage for all applicable conveyances while under its care, custody or control, in an amount of not less than **\$100,000 per shipment.** Government Property must be insured on Replacement Cost (new) basis.
