AMENDMENT 002

This Request for Standing Offer (RFSO) amendment (**002**) is raised to provide clarifications sought by Industry.

1. Questions and Answers:

Question 5: A) Industry has requested information on obtaining a suppliers Business Procurement Number (BPN).

B) Regarding Clause 5.2.1: The link provided to the "Ineligibility and Suspension Policy" does not work. Industry is requesting that Canada provide a correct link?

Answer 5: A) Information on obtaining a BPN is located on the BuyandSell homepage (<https://buyandsell.gc.ca/>), on top right side under the heading "[Help For Businesses](#)".

B) Canada has tested the link (<https://www.tpsgc-pwgsc.gc.ca/ci-if/politique-policy-eng.html>) and determined that the link is working properly.

Question 6: Industry is requesting an extension to the RFSO until 28th of June 2019.

Most of the parts are new and it will take time getting prices.

Answer 6: Canada will not extend the RFSO at this time and the closing date will remain March 29, 2019, 14:00 Eastern Standard Time (EST).

Question 7: Industry cannot import some Line Items with letters inside the NSN Numbers. Line Item numbers are: 173, 374, 647, 696, 845, 967, 1013, 1237, 2141, 2142, 2143, 2144, 2893, 2928, 3006, 3028, 3029, 3030, 3031, 3032, 3182, 3346, and 3362.

Industry request support from Canada with the NCAGE numbers and the manufacturers.

Answer 7: Canada previously provided the answer in amendment 001 dated January 23rd, 2019 at the following link: <https://buyandsell.gc.ca/procurement-data/tender-notice/PW-BL-303-27107>.

Question 8: Industry is requesting clarification to the following:

Article 3.1.1: the RFSO specifies that offers have to be submitted via Canada Post's epost Connect service. This service, however, is only available for Canadian or United States' subscribers. Could European suppliers submit their offers via another electronic method?

Answer 8: European Offerors are required to follow the instructions at Article **3.1.2 under Part 3 - OFFER PREPARATION INSTRUCTION**. As well, clause **2.2 Submission of Offers** provides additional information such as no facsimiles will be accepted and refers to the address (see page 1 of the RFSO) to submit the offer.
