Further to the above-mentioned Invitation to Tender, this **Addendum #1** is to advise potential bidders of the following changes to this tender call and/or answers to Bidders questions received to date:

Question #1:

Item n° 5 - Steel indicate:

It includes the loading, transportation and installation of DFO plates in inventory in the DFO hangar at Gascons Ruisseau Chapados fishing harbor. Plates are of different dimensions (1200 x 2400 x 12 mm) up to 10 m long x 1,2 x 12 mm.

Could you detail the approximate number of plates needed to be transported to complete the project

Answer # 1:

Consolidation work using steel plates is indicated on sections 1, 2 and 3, which represents a length of approximately 55 ml. The vast majority of the plates are 2.44m x 1.22m in addition to a plate of 10m x 1.2m, so around 20 plates are needed for the works.



Question #2:

Does the concrete wall that seems to damage is to be repaired?

Answer # 2

Question #3:

Is it possible to know the composition of the existing riprap (Carapace, filter, all-comer?)

Answer # 3 :

The armor stone would be composed of 4 to 12 mt stone. The composition of the filter stone or the core is not known.

Question # 4

We plan to visit the site sometime next week.
