The following is in response to inquiries received in relation to this solicitation. This amendment will form part of the contract documents.

QUESTION 18

The RFP requires the Prime consultant to provide cost estimates and these will need to be provided by a cost consultant. Under the current RFP there is no requirement for the cost consultant to be a named individual / company such as the structural engineer for example (Appendix A). Can the RFP Appendix A be amended so that the cost consultant is named?

ANSWER 18

PWGSC will not be amending Appendix A to include the Cost Consultant. Please refer to Question #6 in Amendment 2.

QUESTION 19

Reference: 3.2 Rated Requirements, 3.2.1 Achievements of Proponent on Projects

“Select a maximum of three (3) projects undertaken within the last ten (10) years that are of similar scope, multi-purpose spaces and offices, secured facilities, and 7,000 m2 or larger building renovations/ Fit-ups designed and constructed”

The 3 project examples are required to be 7,000 m2 or larger building renovations/fit-ups. The Operations floor, level 5, is just over 1,700 m2 and the office floor is also just over 1,700 m2. Will PWGSC consider project examples of secure office/operation building renovations or fit-ups with similar scale (1,700 m2) or smaller than 7,000 m2 as one or two of our project examples to fulfill this requirement?

ANSWER 19

As per R1410T, Section 3.2: Proposal evaluation and rating:

1. Technical components of all responsive proposals are reviewed, evaluated and rated by a Public Works and Government Services Canada (PWGSC) Evaluation Board in accordance with the criteria, components and weight factors set out in the RFP.

As per SRE, Section 3.2.1, Proponents should clearly indicate how this project is comparable/relevant to the requested project. Should the reference project not be of a similar size, this would be considered and rated appropriately by the Evaluation Board.
