## **Solicitation Amendment No. 001**

### **Title: Portable Restroom Trailer**

(1) This solicitation is hereby amended to provide the following questions and answers:

#### **Question #1:**

Q1: Would a custom design be acceptable?

A1: Yes, a custom design is acceptable but **MUST** include all mandatory requirements as outlined in Annex A.

#### **Question #2:**

Q2: P.14 s 2.2 - Three Season Use, presumably spring, summer and fall. Implying there is no heating system required.

A2: A heating system is not required.

#### **Question #3:**

Q3: P.14 s 2.6 – 8500 lbs gross is an interesting weight for the trailer. Typically axles for trailers are manufactured in 1000 lbs, 3500lb or 6000 lb. Making typical dual axle weights 7000 or 12000 lbs. Is there a specific reason you decided to pick 8500 lbs for your gross weight?

Q3: Section 2.6 specifies a **max** gross weight of 8,500 lbs. as we are looking for a compact and light restroom trailer.

#### **Question #4:**

Q4: P.15 s2.27 – Since your total length is limited to 240", it limits the trailer bed length to about 16'. With a trailer that small, putting a mechanical room in will take away much needed space from the two bathrooms. Would a large electrical box which is sealed to the weather be acceptable?

A4: A separate mechanical room is required as outlined in the requirements.
