THIS AMENDMENT IS RAISED TO ANSWER QUESTIONS FROM POTENTIAL BIDDERS:

- Q1. Pages 87, 88, 89 and 90 of 102 in the RFP are check-off lists; should a response be provided for each line of these tables?
- A1. The Bidders must check-off each box indicating the company will comply with all of the elements of the SOW in any resulting contract. There is no requirement to provide a response for each line item.
- Q2. With respect to Amendment 004, question #5 on the use of Professional Engineers, Canada responded that Canada “allows the use of sub-contracted Professional Engineers, as long as the percentage of the work is in keeping with that allowed for sub-contractor percentage of work”.
- A2. Canada will re-tract its statement in Amendment 004 and state that the Bidder must have at least one Professional Engineer as permanent staff.
- Q3. Following up on the e-mail we send last week, we received info from CSA (see comments below). Based on this e-mail and a conversation we had with CSA, every unit that comes in for any modifications will cost \$\$2-3K per unit by CSA. As this is a sub-contract requirement, the 50% of the MRC cost would be breached every time and negate the statement that no more than 50% of the MRC cost can be sub-contracted. CSA also indicated that an Electrical Engineer is fully capable of doing the work required.
Also note the technical information that is required by CSA to do this work:
- Electrical schematics or wiring diagrams
 - Assembly, mechanical, constructional drawings/details
 - Components lists including manufacturer name, certification status and model/serial number
 - Instruction/installation manual
 - Copy of existing reports (including test data or supportive documents), if applicable
 - Marketing information, line card, photograph or data sheet describing the product
 - Bill of materials – a list of all components or materials used in the product, including the manufacturer’s names, model or catalogue designations, electrical ratings.
- How will DND handle this information?
- A3. Once the product is CSA certified, DND will require all technical information.
- Q4. In responding to the RFP, we need to respond to Annex “D-1” – Bid Evaluation Plan. In Annex D-1 - Bid Evaluation Plan, Stage 1 – Evaluation of Mandatory Requirements, Para. 2.2.1 Mandatory Requirement of the SOW, Annex “A” – SOW Check-Off table. In this table, we find sub-par 7.4 Security Classification, but when we check with the Annex “A” document, at page 40 of 102, that paragraph does not exist, we have 7.4 – Compliance with DND Policies. Please advise if this section (Security Classification is missing in Annex “A” or if it should be removed from Annex D-1?
- A4. Section 7.4 Security Classification will be removed from Table 1 – Annex “A” – SOW check-off table.

All other terms and conditions remain the same.
