The following changes to the Request for Information (RFI) are effective immediately.

Amendment 001 is issued for the following:

(1) Amendment of the RFI

The RFI is hereby amended as follows:

I. Under subsection 2.2 Scope of Project, add the following paragraph:

2.2.1 Accessibility

The Government of Canada is committed to protecting and promoting the rights and dignity of persons with disabilities and works to ensure equality, inclusion and full participation in society for all people. The Canada Pavilion, including its relevant facilities and amenities, will need to be designed so that it can be approached, entered, and used by all people, including those with physical, sensory or cognitive disabilities. The exhibition/public presentation will also need to be accessible to the greatest extent possible for persons with visual and/or hearing impairments.

II. Under section 5 Information Requested, add the following question:

Q6 Accessibility:

Please provide input on how the design and build of the Canada Pavilion can be made fully accessible and how user experience of persons with disabilities could/should be reflected in this design. Please also share information about how the exhibition/public presentation can be made accessible to the greatest extent possible for persons with visual and/or hearing impairments.

(2) Bidders' Questions and Answers

QUESTION # 1:

Can only a company registered in Canada participate in the RFP? Or is it possible for an international company to participate?

ANSWER # 1:

As a future Request for Proposal (RFP) would be subject to international trade agreements the procurement would not be limited to suppliers registered in Canada. International suppliers would be able to participate in the procurement and must be treated in the same way that a Canadian company would be.

QUESTION # 2:

We would like to know if we can receive a notice via e-mail (or via other ways) when the future RFP is announced.

ANSWER # 2:

Interested suppliers are kindly asked to check the Buyandsell.gc.ca website regularly for a future RFP. Estimated timelines for RFP posting are provided in the RFI in Section 3.

Canada reminds interested suppliers that neither the RFI, this Amendment nor any responses to the amended RFI impose any obligation or constitute any commitment on the part of Canada to issue a RFP related to the Canada Pavilion at the Expo 2020 or to make any award of business to any respondent to the RFI.

QUESTION # 3:

Is the RFI applicable to an audio visual integration company looking at a single element of the entire Pavilion project or at this point are you only addressing turnkey providers looking at the project as a whole?

ANSWER # 3:

The purpose of the RFI is to solicit information and feedback from industry with regard to all aspects of the opportunity which includes the public presentation/exhibition components within the Canada Pavilion. Although responses should be as comprehensive as possible, it is understood that

companies can only provide information and feedback within the area of their expertise. Responses from specialized companies as well as from turnkey providers would be equally appreciated.
