Question 1

"The solicitation notes March 29 2019 as the date for full design, and May 31 for delivery of fabricated items.

On page 18, however, it notes:

Exhibit/display construction completed (by March 18th, 2019)

On page 18 it also notes

First draft design to be submitted to DFO for review within 1 month past award of contract.

Based on solicitation closing on Feb 26, an award within a few days, that would put the first draft submitted approximately March 29, but that is noted as the date for completion of full design.

That would leave no time for client review, incorporation of revisions, translations and final artwork production.

Can you clarify the timeline?"
