### **3.2.5 Project Personnel Expertise and Experience**

1. *What we are looking for:*  
A demonstration that the Proponent has project personnel with the capability, capacity and expertise to provide the required services and deliverables listed in the Required Services (RS) section.
2. *What the Proponent should provide:*
  - a) a maximum of two (2) pages per key project personnel (those individuals involved with the majority of the work during individual call-ups) which outlines:
    - a. a summarized C.V. that clearly indicates the years of experience the key project personnel has in the provision of the services specified in the Required Services (RS) section, the number of years of experience with the firm and descriptions of relevant work experience, and
    - b. a description of the potential roles and responsibilities the project personnel will play during individual call-ups.
  - b) a paragraph on each of the other project personnel who will act in a supporting or back-up role to the key project personnel. The paragraph will contain basic information such as names, qualifications, years of experience and role during individual call-ups.
