Addendum no. 1

Questions and Answers

Q1: Section 00 21 13 Clause 1.17.3 - states that an auto-scrubber will be provided. Who is responsible to provide this?

A1: The floor scrubber will be supplied by the Contractor.

Q2: Section 01 35 35 Clause 1.03 – fire extinguishers must be provided. Who is responsible for this?

A2: The Contractor is not required to supply fire extinguishers. Fire extinguishers will be provided by DND

Q3: Is 1 person required at each location for 8 hours a day?

A3: All locations require 1 person for 8 hrs except Fredericton which will have a second person working for half days. This can be calculated from the Basis of Payment in Annex B
