If no other supplier submits, on or before the closing date, a statement of capabilities meeting the requirements set out in the ACAN, a contract will be awarded to the pre-selected supplier.

OBJECTIVE

The objective of the project is to assess the extent to which the marketplace rewards products based on nutritional profile in a Canadian context using actual retail sales data in five categories of processed food products.

SCOPE OF WORK

The Contractor will prepare a report, in Microsoft Excel, containing the following elements:

Retail sales for branded items in the: 1) salty snacks; 2) cookie; 3) chocolate bars; 4) ready-to-eat cereals; and 5) yogurt product categories, including:

- Tonnage Volume (Kg's)
- Tonnage Volume (% Change)
- \$ Volume
- \$ Volume (% Change)
- Average All Commodity Distribution
- Average Retail Price/Tonn.

Period: the most recent 52-week period of data (i.e. ended October 13, 2018, or later).

Region: National

Channels: All Channels (Grocery Banners + Drug + Mass Merchandisers)

Additional information:

- Product description and Universal Product Code (UPC);
- Manufacturer;
- Brand; and,
- Size

Data will also include a Total Control Label line for each category (i.e. private labels), as well as an active item listing for each category.

ESTIMATE OF COSTS

Contract will commence at contract award to March 31, 2019. The estimated value of the contract is \$37,710.00 (plus applicable taxes).

MINIMUM ESSENTIAL REQUIREMENTS

Any interested supplier must demonstrate by way of a statement of capabilities that it has the capacity to provide the same services listed in the support plan listed above

GOVERNMENT OF CANADA REGULATIONS EXCEPTION

The Treasury Board's Government Contract Regulations, Part 10.2.1 Section 6 states there are four exceptions that permit the contracting authority to set aside the requirement to solicit bids. This includes:

d. "only one supplier person or firm is capable of performing the contract."

LIMITED TENDERING PROVISONS IN ACCORDANCE WITH THE TRADE AGREEMENTS

The North American Free Trade Agreement, the World Trade Organization - Agreement on Government Procurement, and the Agreement on Internal Trade permit the contracting authority to set aside the requirement to solicit bids under the following condition:

b) "For works of art, reasons connected with protecting patents, copyrights, other exclusive rights, or proprietary information or where there is an absence for technical reasons, the goods or services can be supplied by a particular supplier and no reasonable alternative or substitute exists"

JUSTIFICATION FOR THE PRE-SELECTED SUPPLIER

Given ACNielsen's proprietary databases of scanned sales transactions at retail point of sale, it is uniquely and solely positioned to provide comprehensive market information for food sales in specific food product categories in Canada. This data is not available from any other supplier as ACNielsen has exclusive rights to retail data.

SUPPLIERS RIGHT TO SUBMIT A STATEMENT OF CAPABILITIES

Suppliers who consider themselves fully qualified and available to meet the specified requirements may submit a statement of capabilities in writing to the Contracting Authority identified in this Notice on or before the closing date of this Notice. The statement of capabilities must clearly demonstrate how the supplier meets the advertised requirements.

The closing date and time for accepting statements of capabilities is March 7, 2019 at 2:00 p.m.

Suppliers that have submitted a statement of capabilities will be notified in writing of AAFC's decision to proceed to award the contract without a further additional tendering process.
