 - c. obtain the required minimum of 90 points overall for the technical evaluation criteria which are subject to point rating.
The rating is performed on a scale of 300 points.
2. Bids not meeting (choose "(a) or (b) or (c)" OR "(a) or (b) or (c) and (d)") will be declared nonresponsive.

Maximum score: 100

Rating scale:

- 50 points: between 50% and 100% of projects are located between 501km and 1000km radius of the Manoir Richelieu.
- 100 points: between 50% and 100% of projects are located in the 500km radius of the Manoir Richelieu.

Canada reserves the right to verify the geographic coordinates of projects with a georeferenced system or by using Government of Canada's topography services.

*The total points will be calculated using the weighted average method.

For example :

In all the proposed carbon credits : 50% of the carbon credits date from 2018 (January 1st to December 31st, 2018) + + 40% of proposed carbon credits are issued from January 1st, 2012 to December 31st, 2017 + 10% of the proposed carbon credits are issued before January 1st, 2012, the total number of points will be : 50 points x 0.5 + 30 points x 0.4 + 0 points x 0.1 = 37 points

- 50 points : 100% of the proposed carbon credits are vintages from January 1st, 2016 to December 31st, 2018;

- 30 points : 100% of the proposed carbon credits are vintages from January 1st 2012 to December 31st, 2015;

*The total points will be calculated using the weighted average method.

For example :

In all the proposed carbon credits : 50% of the carbon credits date from January 1st, 2016 to December 31st, 2018) + 40% of proposed carbon credits are issued from January 1st, 2012 to December 31st, 2015 + 10% of the proposed carbon credits are issued before January 1st, 2012, the total number of points will be : 50 points x 0.5 + 30 points x 0.4 + 0 points x 0.1 = 37 points
