QUESTIONS AND ANSWERS

Question #1 - In Annex A, Statement of Work, under the heading "Objectives", it states that the estimated time is 8-25 hours/week for the duration of the contract. Would Canada consider a flexible working schedule? Ie. If the physician is available for one full week per month, would that be acceptable?

Response #1 - No. We require an Occupational Health Physician who is available between 8-25 Hrs/week to respond to the occupational health needs of our Employees.

Question #2 - Further to Annex A, Statement of Work, under the heading "Objectives", would hours/appointments given be spread out throughout the week? Or would the physician have all patients cluster scheduled to maximize work days as much as possible?

Response #2 - The appointments/meeting/discussions etc that the Occupational Health Physician would have are spread throughout the week on an "as and when required / requested basis" in order to handle the situations that arise with our Employees. The Occupational Health Physician would be expected to attend site, at minimum, once a week for their weekly requirement of (8-25 hours).

Question #3 Are the requested services for the above referenced solicitation currently being provided or have they been provided previously? If so, please identify the means by which such services have been supplied (e.g., direct and or term employee, personal services contract, or contracted services through a company). If the services were contracted through a company, please provide the name of the contractor and the duration and dollar amount of the contract(s).
