AMENDMENT 001

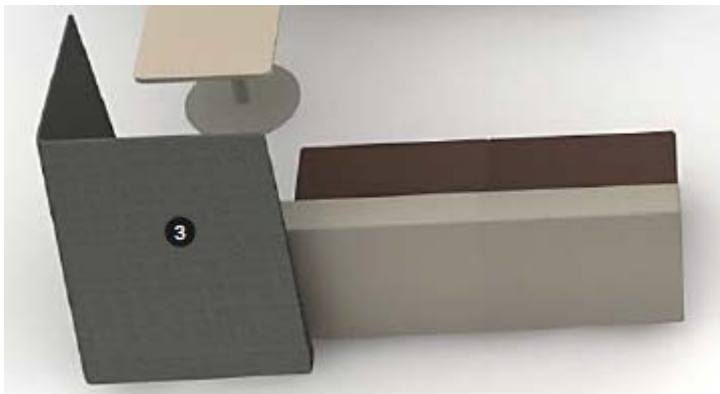
Amendment 005 is being raised to answer the following questions.

Q1: Regarding Item 1. SREBRQPPDHUSAWDSTOMABCTF467243541935 max width of 45", the description calls for 66"W. Should the GoCUID be updated to SREBRQPPDHUSAWDSTOMABCTF467243541935?

Also per the description, this unit is not a sofa, but a ganging banquet unit with a corner unit.

A1: We want an armless sofa with a separate corner screen similar to the sofa pictured below. SREBRQPPSTWSAWUSOOMABCTF234543541935 I believe that this is the correct code but we require a corner screen.

Note: the width of the couch (ganging banquette) on the my initial search was different and I believe that it is available in 66" wide



Q2: Regarding Item 2. SREBMQPPSTDSAWUSOOBABCTF2535NIL1934 is for a modular ganging unit not a lounge chair, are these components meant to gang?

A2: We are looking for a single person bench type seat without arms similar to picture above only shorter (25-35 inches wide) - when working in the CST I chose one seat, 25-35 inches wide, no arms and went from there.

I believe that this is the code for the single seater REBMQPPSTDSAWUSOOBABCTF2535NIL1934 I searched modular benching, with 4 legs and carpet glides, without square side table, one seat, hardwood frame, with Velcro attachment, fabric, 19-34.5 depth, 25-35 width.

Q3: Regarding Item 4. Would the CA Accept TRFTPTARNILTS LPCW60xxNILNIL30xx T-leg equivalent?

A3: That the t leg would be acceptable (they are for our training room so we want them to be mobile and easy to store away that is why the flip-top table was our first choice).

Q4. Is a furniture layout available?

A4 The furniture is for different areas. I have a document featuring drawings of each of the areas with ideas for furniture selection however the furniture is manufacturer specific.
