Q1) *Main RFP document*

On page 3 of the main RFP document, there is a table with quantities of 23 designators split in Qty 2 + 15 + 6, what is it for? It does not match with annex D deliverables planning (2 + 21).

A1) Please see revised Annex D attached to this amendment.

Q2) The paragraph 3.1 of main RFP document means that we cannot submit our offer on a A4-format paper, right?

A2) No. You may not submit on A4-format paper.

Q3) Relative to the 4.2.2.: to my understanding, we are allowed to submit our proposal in Euros, if we precise explicitly the financial proposal is in EURO currency, can you confirm?

A3) Bidders may submit their bid in the currency of their choice. However, it will be converted into Canadian currency for the purpose of evaluation and this process is defined in Section 4 of the RFP.

Q4) Part 5, certifications: are those documents necessary if we have no experience of convicted offences (5.1.1.); if we are a foreign company (5.2.2.)? What are your recommendations due to this paragraph?

A4) Yes, all Bidders wishing to do business with Canada must provide those documents and are subject to a verification prior to contract award if they are the successful Bidder.

Q5) *Annexes*

In the Annex C (technical matrix): the part from line 140 (FR) / 147 (ENG) onwards ("System Performance Specification Rated Requirements Scoring Matrix") is to be filled by CILAS or later on by the evaluation committee?

A5) Yes, they need to select from the pull-down menu what their response is. In the case of the specification on system weight and system volume, there is no pull down menu. The bidder needs to enter their response manually. The bidder should also provide a breakdown of the system weight in their response.
