All other terms and conditions remain the same.

Addendum no. 4

1. **QUESTION AND ANSWER**

Q1: Can you provide the description of products, the estimated amount of product required, the number of dispensers and a list of equipment?

A1: The description of the products can be found in specification section 00 21 13, subsection 1.15. The minimum list of equipment is described in specification section 00 21 13, subsection 1.17. We cannot provide the estimated amount of product required, but the estimated occupancy for each building is as follows:

- **Fredericton:** 5-25 daily; up to 75, 4-5 nights a week.
- **Woodstock:** 2-5 daily; up to 75, 4-5 nights a week.
- **Grand Falls:** 2-5 daily; up to 50, 4-5 nights a week.
- **Edmundston:** 5-10 daily; up to 50, 4-5 nights a week

The number of dispensers for each building are as follows:

- **Fredericton:** 9 toilet paper dispensers, 7 paper towel dispensers and 7 soap dispensers.
- **Woodstock:** 5 toilet paper dispensers, 6 paper towel dispensers and 6 soap dispensers.
- **Grand Falls:** 7 toilet paper dispensers, 7 paper tower dispensers and 7 soap dispensers.
- **Edmundston:** 8 toilet dispensers, 8 paper towel dispensers and 7 soap dispensers.
