GC 1.6 Indemnification by the Contractor

GC 1.6.1

It is a standard industry practice to have a time limitation for indemnification period. To be fair and equitable please consider adding below sentence at the end of GC 1.6.1:

1.6.1. The Contractor shall indemnify and save Canada harmless from and against all claims, demands, losses, costs, damages, actions, suits, or proceedings whether in respect to losses suffered by Canada or in respect of claims by any third party, brought or prosecuted and in any manner based upon, arising out of, related to, occasioned by, or attributable to the activities of the Contractor in performing the Work, provided such claims are caused by the negligent or deliberate acts or omissions of the Contractor, or those for whom it is responsible at law and are made in writing within a period of six (6) years from the date of Substantial Performance of the Work.

1.6.5 Notice in writing of a claim shall be given within a reasonable time - 30 days after the facts, upon which such claims based, became known.
