Title - Sujet

Catering Services – Palisades Centre, Jasper, AB.

Amendment No. 002 is to address bidder questions raised at the mandatory site visit.

- **Q1:** How many staff are required to be on site for catering?
- A1: It is up to the contractors to determine the required number of staff to deliver service.
- **Q2:** How many rooms are available for staff accommodation and how many people can be in a room?
- A2: There are four separate bedrooms in the Bunkhouse. Two are allocated to Catering staff, and two are allocated to Housekeeping staff. Rooms can accommodate one double or queen-sized bed, or two single beds. No more than two people can be housed in a room, and those staff must be here performing work for the Palisades Centre contract.
- **Q3:** How are contractors told about the numbers of people that need to be fed?
- A3: A list is given to the cook (known as a "cook count") that has the number of people that are eating and any food restrictions they may have. We make every attempt to provide 7 days notice or more, and 48 hours' notice of any changes to the numbers of people or food restrictions.
- **Q4:** Are the guest numbers in the contract (3000) an approximate amount or an accurate amount?
- A4: The numbers are based on an average of the annual numbers of visitors over the past 3-4 years.

ALL OTHER TERMS AND CONDITIONS REMAIN UNCHANGED.
