1. This amendment is raised to respond to questions from Industry.

**Q1. We have the following initial questions:**

**1. The Description reads like you are only looking for one supplier to provide the 8 different services. Is this correct? Or are you looking for one supplier per service?**

**2. If only one supplier total, would you consider breaking the RFP into separate services? It would be very difficult for a small- or medium-sized business to qualify for all 8 of these services. You may be inadvertently giving preference to large firms.**

1. Yes, one Supplier for all services.
  2. The Work required under the resulting contract requires that there be continuity between the services offered, which would be difficult with multiple suppliers. Canada has considered the question but is not able to break-up the services into separate offerings.
