1. Solicitation closing date extension

Solicitation closing date is postponed from March 13 to **March 27, 2019 at 14h00.**

2. Questions 12 to 14

Question 12:

The manufacturer Quest is specified for Items 2, 3 and 5. It appears that Quest belongs to a commercial kitchen equipment distributor. Since these products are normally exclusive to this distributor, we would like equivalents to be specified.

Answer 12:

We cannot name other equivalent products. We have included specific characteristics to be met in accordance with the presented models as examples.

The equivalence criteria's for items 2, 3 and 5 are mentioned in the table of Annex D. So any product meeting these criteria's will be considered.

Question 13:

Also - this is just an observation on the process - we think that a contract awarded as a whole and not by lot as specified in Addendum 1 (examples: manufacturers' equipment, custom equipment, hoods) limits the possibilities that some suppliers are bidding on this project.

Answer 13:

We are aware of the situation, however, we accept that a supplier obtains the support of subcontractors for all aspects of this requirement in order to present a complete bid.

Question 14:

For Item #7, the Vapor Dragon VS4000C, when looking online, there seems to possibly be unit online available as 4000-C with 120v electrical. We have concern firstly on the electrical as relates to what is shown on Addendum 1, and also that this is the correct model desired.

Please confirm if this is something that is remaining in the scope, and if needs to be quoted in the Kitchen scope.

Answer 14:

Yes, this item remains with a model number correction, the manufacturer has been updating their product reference number, new number model is VC 4000-C, 120 volts

3. Modifications to the solicitation

A. Under PART 2 - BIDDER INSTRUCTIONS clauses 2.5 and 2.6:

2.5 Bidders' Conference (Optional)

An optional bidders' Conference chaired by the Contracting Authority will be convened on board vessel CCGS Martha L. Black at **13h00, March 18, 2019**. Because of the current vessel operations, the location at which the vessel will be moored is unknown at this time and will be determined at a later date via a solicitation amendment.

An attendance confirmation will be required before 11:00 am, March 15, 2019.

It is recommended that the Bidder or a representative of the Bidder attend the Bidders' Conference in order to review the Scope of the Work required and to receive additional information and clarifications. Bidders are to communicate with the Contracting Authority prior to the conference to confirm attendance. Bidders that do not attend are not precluded from submitting a bid. Bidders are to provide the Contracting Authority with the names of their representatives no later than two days prior to the conference. The Contracting Authority will have an attendance form which is to be signed by the Bidder's representative(s) in attendance. Bidders are advised that any clarifications or changes resulting from the Bidder's conference and/or the subsequent viewing of the vessel, shall be included as an amendment to the bid solicitation document.

2.6 Viewing - Vessel (Not mandatory)

An optional site visit will be held immediately after the bidders' conference.
