NOTE: This Statement of Work includes two (2) emergency calls for the full term the contract per site at no extra cost to Canada. Any additional emergency calls will be at extra cost to Canada. In the event that travel and accommodation are required for the two (2) included Emergency Calls, the cost must be approved by the Departmental Representative in accordance with Annex A, Scope of Work, Clause 1.4.3.2.
