STATEMENT OF REQUIREMENT
FOR AN ADAPTOR, MICROPHONE
FOR THE ROYAL CANADIAN AIR FORCE**

1.0 SCOPE

1.1 Purpose

The Royal Canadian Air Force (RCAF)/Department of National Defence (DND) has an immediate requirement for an adaptor, microphone. This statement of requirement (SOR) defines the requirements for the acquisition.

1.2 Background

The RCAF Aircrew presently have a communication cord that allows them to operate safely, effectively and securely during operations.

Current RCAF communication cords have a tempest secure transmission capability. The required adaptor is a means to allow non-secure communication cords to connect to the aircraft communication system, which requires a TP106 connector.

2.0 REQUIREMENTS

- 2.1** The microphone adaptor must comply with the technical requirements under NSN 5965-01-319-5363.
- 2.2** The microphone adaptors must meet delivery schedule of required under section 2.3.3

2.2.1 Reliability and Durability

- a. The adaptor, microphone must be durable and able to sustain daily use in training and mission scenarios.
- b. The adaptor, microphone must remain serviceable for a minimum of three years under normal use and a minimum of 5 years of combined storage and normal use following OEM maintenance instructions; and
- c. The contractor must warrant the adaptor, microphone to be free from defects in material and workmanship under normal use and service for a period of 1 year from the date of delivery.

2.2.2 Certification

- a. The adaptor, microphone must comply with applicable federal safety standards.

2.2.3 Delivery Schedule

- a. The Contractor must provide DND with fifty (50) microphone adaptors within 10 days after contract award;
- b. The Contractor must be able to provide DND with an additional one hundred fifty (150) microphone adaptors within **thirty** (30) days after contract award, if required.

QUESTIONS TO BE ANSWERED ON RESPONSE TO RFI

1. Must provide a point of contact, if further questions or clarification is required.
2. An estimation of the cost and the schedule regarding the requirement. Alternate delivery schedules that beyond 30 days of the contract award will not be considered. The supplier has the obligation to demonstrate how he/she will meet this requirement (i.e. product is already available in stock, quantities immediately available).
3. Are there elements that prevent the contractor from providing these adaptors within the required timelines obligated by this request for information?
