4.1.2.1 Mandatory Financial Criteria

The price of the bid will be evaluated in Canadian dollars, Applicable Taxes excluded, FOB destination, Canadian customs duties and excise taxes included.

The Bidder must submit pricing in accordance with Annex B, Basis of Payment, with their bid at bid closing.

The price used in the evaluation will be the Total Evaluation Cost which is calculated as follows:

Total Evaluation Cost is the sum of the Total Extended Category Price for category 1 and Total Estimated Extended Category Prices for categories 2-3.

For category 1, the Usage for each line item will be multiplied by the Firm Unit Price to determine the Extended Price for that line item. The sum of all line items will be used to determine the Total Extended Category Price.

For categories 2-3, the Estimated Usage for each line item will be multiplied by the Firm Unit Price or Firm Unit Rate to determine the Extended Estimated Price for that line item. The sum of all line items will be used to determine the Total Estimated Extended Price for each category.
